SUBJECT: Call for applications for admission to the 41st cycle of PhD programmes administered by the University of Sassari.

THE RECTOR

- **HAVING CONSIDERED** the Statute of the University of Sassari, published on the Italian Official Journal no. 298 dated 23 December 2011;
- **HAVING CONSIDERED** art. 4 of Law no. 210 dated 3 July 1998, providing that Universities are entitled to implement internal regulations for the management of PhD Programme;
- **HAVING CONSIDERED** the Regulations on PhD Programmes of this University approved by Rector's Decree no. 2064 dated 03/07/2025;
- **HAVING CONSIDERED** Ministerial Decree no. 224 dated 30 April 1999, published on the Italian Official Journal no. 162 dated 13 July 1999;
- HAVING CONSIDERED Italian Law no. 240 dated 30 December 2012, and in particular art. 19;
- HAVING CONSIDERED Ministerial Decree no. 226 dated 14 December 2021;
- **HAVING CONSIDERED** the *Post-graduate Tuition Fees and Charges and State exams* referred to in R.D. 3160 no. 121490 of 24 December 2019.
- **HAVING CONSIDERED** Ministerial Decree dated 23 February 2022, n. 247 on the Annual gross increase for PhD scholarships;
- **HAVING CONSIDERED** *The public call for applications for PhD scholarships* Year 2025 published by the Autonomous Region of Sardinia with Resolution No. 441 of 13/06/2025 for the funding of PhD scholarships under the "PR Sardegna FSE+ 2021-2027 al servizio della dignità" (Sardinia ESF+ 2021-2027 in the service of dignity) for support from the European Social Fund Plus under the objective "Investments for employment and growth" CCI 2021IT05SFPR013 Priority 4 "Youth employment" Intervention sector Code 150 "Support for tertiary education (excluding infrastructure)" Specific Objective ESO4.6. f): promoting equal access to and completion of inclusive and quality education and training, in particular for disadvantaged groups, from early childhood education and care, through general and vocational education and training, up to tertiary level and adult education and learning, including by facilitating learning mobility for all and accessibility for people with disabilities (ESF+);

HAVING CONSIDERED the project proposal submitted by the University of Sassari on 27/06/2025;















- **HAVING CONSIDERED** Resolution No. 513 of 04/07/2025 of the Autonomous Region of Sardinia, which approves the minutes of the Commission's proceedings and the ranking of eligible project proposals, including that of the University of Sassari;
- HAVING CONSIDERED the RAS note no. 8422 of 08/07/2025, which informs the University of Sassari of the allocation of total funding of €4,900,000, of which €3,500,000 is for Line A and €1,400,000 is for Line B, and at the same time authorises it to proceed with the publication of the call for applications pending the signing of the agreement;
- **PENDING** the signing of the agreement with the Autonomous Region of Sardinia for the benefit of the PR Sardegna FSE+ 2021-2027 funding;
- **HAVING CONSIDERED** the MUR note of 29/04/2025 Prot. no. 8936, which set out the operational guidelines on the accreditation procedures for Doctorates for the academic year 2025/2026;
- **RECALLING** the proposals for the activation of the XL cycle of PhD Courses with administrative headquarters at the University of Sassari put forward by the structures responsible for research activities, as reported in the national database;
- **HAVING CONSIDERED** the agreement with the University of Cagliari dated 07/06/2024 for the activation of the PhD Course in Chemical Sciences and Technologies;
- **HAVING CONSIDERED** the positive results of the ANVUR evaluations of the PhD Courses for which accreditation was requested for the XLI cycle, communicated on 11/07/2025;
- **HAVING CONSIDERED** the resolutions of the Academic Senate and the Board of Directors, both dated 23 July 2025, regarding the activation of the XLI cycle and the related competitive procedures;
- **CONSIDERING** the possibility that there may be increases in the funds available for the financing of doctoral scholarships or that additional and different sources of funding may become available, even after the deadline for the call for applications, reserving the right in such cases to take action that will be made public on the University website;

DOES HEREBY DECREE AS FOLLOWS:

ART. 1 – Announcement

A public selection is announced at the University of Sassari for the award of PhD positions – XLI cycle in the A.A. 2025/2026.

Calls based on qualifications and examinations are open for the admission to the PhD Programmes listed in Annex 1 and reporting the number of positions available, the number and type of scholarships, the qualifications which will be subject to evaluation by the Selection committee, the research topics required for the sole purpose of the selection procedure.

The scholarships funded by PR Sardegna FSE+ 2021-2027 resources are aimed at young graduates under the age of 35, with the aim of increasing opportunities for economic development and employability, including by promoting connections between the academic world and socio-economic spheres, with a particular focus on the strategic missions and priorities of the regional S3. Furthermore, as the Region of Sardinia intends to implement its gender equality strategy and, in line with the Sardinia ESF+ 2021-2027 Regional Programme, aims to promote the reduction of the gender gap in the field of STEM (Science, Technology, Engineering and Mathematics) disciplines, in addition to the above-mentioned PhD scholarships, aimed at deserving students of both sexes, PhD scholarships will be funded in the STEM area, particularly in the Green and Blue Economy and ICT sectors, aimed solely at women, who, at the end of their PhD programme, will be highly qualified with greater job opportunities and the possibility of holding senior positions in the socio-economic world.

The Region of Sardinia funds PhD scholarships related to the two lines of action specified below:

LINE A: Doctoral scholarships for projects closely linked to the needs of businesses in sectors that are strategic for the regional economy (S3, internationalisation, innovation, climate and energy transition, and environmental, social and governance sustainability), aimed at young graduates under the age of 35 (men and women).

LINE B: Doctoral scholarships linked to the business system to promote the participation of female researchers in STEM subjects and, in particular, in the Green and Blue Economy and ICT sectors, aimed at young female graduates under the age of 35 (women only).Le borse di studio sono così suddivise:

If additional scholarships become available within the deadline of this Notice, it may be supplemented with the relevant positions. The scholarships covered by this competition will only be definitively awarded following confirmation of funding by the respective funders.

ART. 2 – Admission requirements

Applicants may apply for admission to PhD Courses, as per the previous article, specifying the exact name of the curriculum, only for those Courses that provide for them, who hold a specialised or magistral degree awarded in accordance with the DD.MM. 3 November 1999 no. 509 and 22 October 2004 no. 270, or a degree obtained under the previous university system (prior to D.M. no. 509 of 3 November 1999) or other equivalent qualification obtained abroad.

Candidates for scholarships funded by the PR Sardegna FSE+ 2021-2027 must also meet the specific requirements set out in Article 4 below.

Foreign citizens in possession of a qualification that has not already been declared equivalent to a university degree must - solely for the purpose of admission to the PhD Course to which they intend to apply - accompany the application form, according to the procedure described in art. 7 below, with the documents necessary to allow the Selection Committee to declare equivalence. Said documents must be translated into Italian or presented in English, French or Spanish and legalised by the competent Italian diplomatic or consular representations abroad in accordance with the regulations in force for the admission of foreign students to degree courses at Italian universities.

Foreign applicants who do not have any document translated as above, may submit a self-certification stating their compliance with the relevant requirements. Applicants shall then be admitted sub condicione and, should they be selected, they will be required to submit the above documentation **by 31/10/2025**,















under penalty of exclusion.

For the Italian applicants having a foreign academic qualification yet to be validated as equivalent to an Italian laurea degree, the same provisions apply.

Simultaneous enrolment of students in two courses of study is permitted in accordance with Law No. 33 of 12 April 2022 and its implementing decrees.

Attendance to joint medical specialization Programme and the PhD Programme is governed by art. 7 and 9.1 of Ministerial Decree no. 226 dated 14 December 2022.

Candidates applying for reserved places may be admitted to PhD Courses if they are successful in the competitive examinations referred to in articles 8 and 9 of this notice.

Those interested must draw up their applications according to the procedure described in the following articles 6 and 7 of this call.

Those who have obtained the qualification referred to in Article 2 by the deadline for applications may participate in the competition.

All candidates, including those applying for the reserved places referred to in Article 3 below, who do not hold the required qualification by the deadline for applications but will obtain it by 31 October 2025, may also be admitted on a conditional basis. The start date of the 41st cycle of PhD Courses at the University of Sassari for this selection is 1 November 2025.

All candidates, including those competing for a reserved place, who are admitted *sub-condicione* and are successful in the competition procedures, must submit a self-certification of their qualification to the Higher Education Office of this University by 31/10/2025 at the latest.

<u>Candidates who fail to communicate the attainment of their degree within the specified time frame</u> or who submit incomplete or incorrect communications will be excluded.

ART. 3 – Positions reserved

Each PhD Course has the right to reserve places for candidates who meet certain requirements. Candidates who opt for these types of places must explicitly request them in their application form and must also be successful in accordance with the provisions of Articles 8 and 9 below.

Candidates for positions reserved for members of the Guardia di Finanza (Italian Financial Police) must submit Annex 3, certifying the required information, under penalty of exclusion from the competition.

Candidates who are successful in positions reserved for foreign scholarship holders must submit documentation certifying their status to the Higher Education Office of this University by 31/10/2025 at the latest.

ART. 4 – PR Sardegna FSE+ 2021-2027 Scholarships

Candidates for positions with scholarships funded by PR Sardegna FSE+ 2021-2027 must be under 35 years of age at the time of submitting their application. Only female candidates may apply for scholarships funded under Line B (STEM). Candidates who do not meet the above requirements at the time of submitting their application will be automatically excluded from the competition.

The PhD programme of PhD students receiving scholarships funded by the PR Sardegna FSE+ 2021-2027 must be carried out in Sardinia, except for periods of study and research abroad, planned in line with the training and research activities provided for by the PhD Course, and must be completed (award of degree) by 31 December 2029.

The recipients of scholarships referred to in this article must complete a period of study and research abroad of at least six months (even if not continuous) during the three-year period.

Doctoral students who do not complete the minimum period of six months abroad or do not obtain their degree by 31 December 2029 (including those who withdraw from the Doctorate programme) will be required to repay the scholarship.

ART. 5 – Vinci 2025 Scholarship Programme

The position with a scholarship funded by the Vinci 2025 Call for Applications requires the activation of joint supervision of the thesis with the Université d'Angers (France) and the awarding of a double degree.

The doctoral student benefiting from the scholarship referred to in this article must carry out their research period at both locations, and at least six months (not necessarily consecutive) must be carried out at the Université d'Angers.

ART. 6 – Application procedure

The application to take part in the competition must be drawn up in accordance with the procedures and deadlines indicated in Article 7 below.

In the application, the candidate must indicate under his/her own responsibility, under penalty of exclusion from the competition:

- A. last name and first name, date and place of birth and permanent address;
- B. citizenship;
- C. degree awarded, date of issue of the degree and awarding University, or the equivalent certification issued by a foreign University;
- D. the selection of the *sub-conditions* option in the call, with an indication of the University to be issuing the qualification and the name of the qualification. To certify this condition, the applicant will be required NOT to fill the form fields regarding the date of qualification and the relevant result;

E. the contact address for the purposes of the call. EU citizens and foreigners must indicate an Italian physical address or the details of the the Embassy of their country in Italy, selected as reference address. Any change in the aforementioned address must be promptly notified to the Higher Education Office, by e-mail by writing to helpesse3@uniss.it or rnzallu@uniss.it.

The application **must** also include a copy of the applicant's ID (front and back) featuring a visible picture allowing the identification of the applicant.

Under penalty of exclusion from the competition, together with the application form, a research project **must** be submitted on the topics indicated for the positions for which the candidate is applying, as set out in Annex 1. To this end, candidates may use the template provided in ANNEX 2 of this competition notice published on the website <u>www.uniss.it</u>. For PhD Courses that have opted for the "Qualifications + interview" assessment method, the research project will not be subject to scoring. However, even in this case, the submission of the research project together with the application form is mandatory, under penalty of exclusion from the competition. Under no circumstances will the submission of the research project in any manner other than that described in Article 7 below be accepted.

The following qualifications submitted by candidates together with their application to participate in the competition within the deadline and in accordance with the procedures set out in Article 7 will be evaluated:

1. copies of scientific publications, up to a maximum of 5 (no more than 5, strict limit);

2. a numbered list of the scientific publications referred to in point 1 (only the first 5 on the list will be considered; if the list is not submitted, no points will be awarded for the publications);

3. self-certification, pursuant to Articles 46 and 47 of Presidential Decree 445/2000, concerning other university qualifications such as second-level Master's degrees, specialisation schools, research grants, and foreign postgraduate qualifications equivalent to those listed.

Applicants may also attach their CV's to the application form. This will not, in any case, be awarded any point by the Selection committee and failure to do so will not hinder the applicants' participation in this competition. The presentation of a Bachelor's degree, if any, is not required and will not be evaluated in any case.

Both the ID (front and back) and the research project, and any additional qualification and Curriculum Vitae must be attached, preferably in PDF format, in accordance with the procedures reported in the "Guidelines for applicants to public calls" published on the same page of the University of Sassari website where this call is published. Should the uploaded files not be readable, even after the use of a digital format other than PDF, the University will not be liable for such problems.

Pursuant to art. 15 of Law No. 183 of 12/11/2011, as of 01/01/2012 it is not possible to request or accept certificates issued by public administrations attesting the status, personal skill of, or facts regarding natural persons. Therefore, any statement referred to in letters A, B, C, and D of this article, shall be submitted in the application for the admission test as self-certification, pursuant to artt. 46 e 47 of PRD 445/2000.

This Administration reserves the right to accept sub conditione applicants to the selection















procedure and the right, at any time, to exclude applicants who are not in possession of the qualifications and requirements set forth in this notice.

No communication will be sent to applicants and all the information will only be published on the www.uniss.it website.

Any amendment/addition to this call shall be published on the official website <u>www.uniss.it</u> by the deadline set by this call.

The application for admission may be submitted for each PhD Course indicated in Annex 1. If the candidate intends to apply for more than one PhD Course, he/she shall submit separate applications for admission and pay the relative fee for each one.

It is permitted to submit several applications for different positions within the same PhD course.

may only apply for admission to the PhD Course in Legal Sciences if they hold a degree in Law or Political Science awarded in accordance with the regulations in force prior to the issue of Ministerial Decree no. 509 of 3 November 1999 or candidates holding a Postgraduate or Master's Degree awarded in accordance with DD.MM. 3 November 1999 no. 509 and 22 October 2004 no. 270 in one of the following Degree Classes:

Candidates who hold other equivalent qualifications obtained abroad may also apply for admission to the PhD Course in Legal Sciences.

Candidates for the PhD Course in Legal Sciences who hold a qualification other than those listed above will be excluded from the competition.

The submission of an application for admission, in accordance with the procedures set out in Article 7 below, implies the candidates' acceptance of the rules contained in this call for applications.

ART. 7 – How to apply

Applications must be submitted, on penalty of exclusion, by **1 pm of 1**st **September 2025 (CET)** <u>only</u> by connecting to <u>https://uniss.esse3.cineca.it</u> and by logging in or registering, if you are signing up for the online services of the University of Sassari for the first time.

Applications must be submitted in accordance with the procedures set out in the document 'Instructions















for submitting applications' published on the same page of the University of Sassari website where this call for applications is published.

If necessary, the application form can be modified directly by the candidate, within the deadline for this notice, <u>exclusively</u> by connecting to the website <u>https://uniss.esse3.cineca.it</u>, logging in, selecting the competition for which the application form is to be modified and clicking on "modify".

In this regard, please refer to the separate Tutorial available at <u>https://www.uniss.it/ateneo/documenti-di-ateneo/tutorial-immatricolazione</u>.

The applications filed, for any reason, after the terms and/or in ways other than those set forth in this call, will not be accepted.

Applicants must submit their application by selecting, within the PhD Course, the administrative category corresponding to the scholarship for which they intend to participate, in accordance with the provisions of Annex 1 to the notice. The choice of administrative category will be binding as the rankings will be divided by administrative category. In the same PhD Programme it is possible to apply for only one administrative category.

The application may be modified by the candidate, also with regard to the choice of PhD course or administrative category, within the deadline established in the present call. <u>Any application received by the Office after this deadline will not be taken into consideration.</u>

It is compulsory to attach through the online procedure the front/back copy of ID/Passport (in a single PDF file format).

Sub-condicione candidates must also certify their status using Annex 3 to the call for applications. Candidates who intend to participate conditionally and who do not submit Annex 3 will be considered ineligible and, consequently, excluded from the competition.

All candidates with disabilities or with specific learning disorders (DSA) are guaranteed the possibility of using compensatory tools for reading, writing and calculation difficulties, as well as the possibility of using an extension of the time set for the same tests, in accordance with the provisions of Article 5, paragraphs 2(b) and 4, of Law no. 170 of 8 October 2010. Applicants with special needs or learning disabilities, pursuant to Law n, 104 of February 5, 1992 a.a.a.s. and Law 170 of October 8, 2010, based on their specific needs, may request assistance as well as extra time for the completion of their exams if they require so, in addition to other measures safeguarding equal opportunities during the test phase.

With specific regard to the granting of additional time for the written tests, candidates with a certificate of disability or certification pursuant to Law no. 104 of 1992, issued by the competent medical commission for the area, proving the type of disability and/or the degree of recognised handicap, will be entitled to an additional time not exceeding 50% over and above the time set aside for the performance of the test. Candidates diagnosed with specific learning disorders (DSA) pursuant to Italian law no. 170/2010, with appropriate certification issued by NHS facilities or by organisations and specialists accredited by the same, will be entitled to additional time not exceeding 30%.

These conditions must be proven by appropriate medical certification issued by the competent health authorities, the validity of which the University reserves the right to verify in accordance with current legislation. Those who have selected the item "Richiedo assistenza e/o servizi di tutorato specializzato" (I request assistance and/or specialised tutoring services) in the on-line enrolment procedure must make an explicit request for the necessary aid by sending an e-mail to <u>mzallu@uniss.it</u>. Failure to indicate your disability status when registering online, or to send an email requesting assistance, does not ensure that the necessary aids will be provided in time for the tests.

Registration for the admission competition will only be considered complete after the correct payment of the €10.00 fee, to be made by **1st September 2025**, through the electronic payment systems provided by PagoPA. (<u>https://www.agid.gov.it/it/piattaforme/pagopa</u>.).

No other form of payment is accepted; therefore, applicants who use electronic payment systems other than those provided by PagoPA will be automatically excluded from the selection procedure.

Under no circumstances will the competition entry fee be refunded.

ART. 8 – Exam

The exam for admission to the PhD Programme takes place in one of the following ways, as chosen by each PhD Programme:

- > qualifications + research project + interview;
- ➤ qualifications + writing + interview;
- ➤ qualifications + interview.

The purpose of the exam is to test the applicant's knowledge, his or her aptitude for scientific research and his or her knowledge of the foreign language selected by the applicant or expressly required by the PhD Programme.

The interview may be held in Italian or English or other EU language, upon request of the applicant and upon approval of the Selection Committee, during the examination session.

As for the interview and any written test, the date, time, place and references will be given for each Course on <u>www.uniss.it</u>.

Applicants shall access the interview upon submission of a valid ID, passport, driving license, or other personal identification card issued by public authorities, submitted together with the application form. Failure to provide such documents will result in the exclusion from the examination procedure.















Candidates should report to the venue indicated or connect to the telematic contacts indicated by the time that will be published on www.uniss.it, in such a way that the Selection Committee has enough time to complete the necessary identification procedures. Applicants who fail to connect to the scheduled conference call will be excluded.

The selection tests are public.

Candidates are aware of the possible technical inconveniences that the telematic mode may entail. The University is therefore not liable for any inconvenience or difficulty due to technical reasons.

The overall merit ranking resulting from the marks obtained by each candidate in the interview, in the research project (if envisaged by the PhD Course), in the written paper (if envisaged by the PhD Course) and in the assessment of qualifications will be published on <u>www.uniss.it</u> following the approval of the competition acts.

ART. 9 – Selection Committees and their duties

The Selection Committee of each Programme will be composed based on the rules of the University regarding PhD Programmes.

The Selection Committee may award up to 100 points for the evaluation of each applicant, divided as follows:

- For the PhD Programmes which have opted for the "qualifications + research project + interview" option
 - > up to a maximum of 30 points for the evaluation of the qualifications;
 - > up to a maximum of 20 points for the evaluation of the research project;
 - \succ up to a maximum of 50 points for the interview;
- For PhD courses that have opted for the option consisting of qualifications, writing and interview
 - \succ up to a maximum of 30 points for the evaluation of the qualifications;
 - > up to a maximum of 35 points for the evaluation of the written paper:
 - \succ up to a maximum of 35 points for the interview.
- For the PhD Programmes which have opted for the "qualifications + interview" option:
 - ➤ up to a maximum of 30 points for the evaluation of qualifications;
 - \succ up to a maximum of 70 points for the interview.

- Publications (up to a maximum of 10 points): a <u>maximum of 5</u> publications (in the case of candidates submitting more than 5 papers, only the first five on the list will be considered) with research topics related to the PhD Programme chosen can be enclosed by the applicant. Only scientific publications with the ISBN/ISMN/ISSN or papers published in journals indexed on "Web of Science" or "Scopus" databases, or otherwise accepted (attach documentation) for final publication will be evaluated.
- Other qualifications (up to a maximum of 5 points): the applicant may indicate <u>only one academic</u> <u>qualification</u> among the post graduate degrees, specialization diplomas, research scholarships, postgraduate qualifications equivalent to those listed. The qualification presented by the applicant must be consistent with the research areas of the PhD Programme he/she intends to apply to. Only the qualifications awarded (or at least completed) from 2020 on, will be considered
- Certification issued by an authorised body attesting to knowledge of a foreign language at level B2 or higher (4 points).

The score assigned to each of the applicants admitted *sub conditione* will not be revised if the applicant successfully passes the selection procedure.

The research project to be evaluated by the PhD Programmes which have chosen that option, must obtain a result of at least 12/20 to be admitted to the interview. In the event of a mark of less than 12/20, the candidate is not admitted to the interview.

The writing, for PhD courses that have opted for its evaluation, must obtain a mark of at least 21/35 for the candidate to be admitted to the interview. In the event of a mark of less than 21/35, the candidate is not admitted to the interview.

The list of selected applicants will be signed the President of the Selection Committee and published on <u>www.uniss.it</u> along with the date, time, place and online reference to connect for the interview.

"Qualifications + research project + interview" option: the interview is passed if the applicant is awarded at least 30/50, according to the following scale

Knowledge of a foreign language, to be assessed testing the written and spoken language skills: max 15 points;

- Discussion of the research project, to be assessed as:

- a) knowledge and ability to apply the scientific method on the research topics: max 15 points;
- b) knowledge and understanding of the research topics and motivations: max 20 points.

– For PhD Courses requesting this in their specific sheet (Annex 1), any letters of reference will be taken into account, to be sent in the manner and in the maximum number described in the said sheet.















"Title + written + interview" option: the oral test is considered passed if the candidate obtains a mark of at least 21/35, according to the following distribution of points

Knowledge of a foreign language, to be assessed testing the written and spoken language skills: max 10 points;

- Discussion of the research project, to be assessed as:

- a) knowledge and ability to apply the scientific method on the research topics: max 10 points;

- b) knowledge and understanding of the research topics and motivations: max 12 points.

"Qualifications + interview" option: the interview is passed if the applicant is awarded at least 42/70, according to the following scale

 Knowledge of the foreign language(s) indicated in the PhD Course outline, assessed as written and spoken ability: max 15 points;

 Motivation, to be assessed as the ability to present his or her motivation to undertake a PhD Programme: max 15 points;

– Aptitude for research, to be assessed as the knowledge and ability to apply the scientific method on concrete examples and relevant to the research topic: max 20 points

 Specific knowledge and skills, to be assessed as the knowledge and understanding of the research topic: max 20 points.

Once the competition tests have been completed, the Commission shall draw up the general merit rankings on the basis of the sum of the marks obtained by each candidate in the assessment of the qualifications, the research project (if any), the written test (if any) and the interview. The rankings shall be divided administrative categories, and the candidate placed in them on the basis of the choice made during the application procedure, and separated for each curriculum, if any, according to the Course Determinations as set out in this call.

The official ranking will be published on the website <u>www.uniss.it</u> following approval of the competition documents.

ART. 10 – Enrollment and Registration

Selected applicants are admitted to the PhD Programme on the basis of the merit list until the full assignment of available positions. They will be required to register, under penalty of exclusion, by the time specified when the merit list is published.

In the event of non-acceptance or late acceptance by the entitled candidates, another candidate shall take















over, according to the order of the ranking list. The starting date of the PhD course for this selection is 1 November 2025.

In the event of a tie between candidates in terms of merit, the younger age will be taken into consideration, pursuant to Article 2 of Law no. 191 of 16 June 1998.

Applications for enrolment by successful candidates must be submitted within the deadline, under penalty of forfeiture of the right to enrol in the PhD Course, and in accordance with the procedures that will be published on the University website <u>www.uniss.it</u> at the same time as the competition rankings.

In order to enter Italy, citizens of non-EU countries residing abroad must register on the portal <u>Universitaly</u> and apply for an entry visa at the Italian Embassy or Consulate responsible for the area.

The renunciation of the scholarship entails the renunciation of enrolment in the PhD Course in the case in which the activation of the consequent position without a scholarship, not provided for in the present call for applications, determines a failure to comply with the ratio (verified in the PhD Course of reference) of one position without a scholarship for every three positions with a scholarship, pursuant to art. 9 paragraph 1 of the Ministerial Decree of 14 December 2021, no. 226.

In the event of the activation of positions without a scholarship following the renunciation of the scholarship, as per the previous paragraph, once the 1 to 3 ratio has been verified, these will be activated giving priority to the candidate with the highest score of the same PhD Course.

In order to improve the recognition and visibility of their scientific output, doctoral students are required to activate an <u>OrcID</u> iD when enrolling in the Doctoral Programme.

ART. 11 – Attendance

All applicants are required to attend and participate in the PhD Programme activities as full-time students, as specified in the Programme requirements approved by the PhD Board.

At the end of each academic year, students will be required to file a detailed report of the research work carried out and their results. The PhD Board will retain the reports, evaluate the regular attendance and productivity of each applicant and recommend the Rector to approve or reject the continuation of the ongoing Programme.

Recipients of scholarships funded by the PR Sardegna FSE+ 2021-2027 and the Vinci 2025 Call for Applications must complete a period of research abroad lasting between over the three-year period, ranging from a minimum of six months to the maximum limit set out in Article 9, paragraph 3, of the Decree of the Ministry of University and Research No. 226 of 14 December 2021, under penalty of having to return the scholarship.

The PhD degree will be awarded at the end of the course following the successful evaluation of a research















thesis by a specially appointed Committee.

ART. 12 – Scholarship rejection or withdrawal

Those who have not regularised their enrolment by the aforementioned deadlines shall be deemed to have withdrawn and those who have made false declarations, in addition to the criminal liability they will incur, shall be declared dismissed.

If there are no suitable candidates within one or more curricula, or in the event of renouncement or forfeiture of the rightful candidates, the Course Committee may propose to the Rector the redistribution of the places available among the activated curricula.

ART. 13 – Scholarships

The scholarships, the number of which is indicated for each PhD programme in Annex 1, are awarded after a comparative assessment of merit and according to the order defined in the respective merit rankings, either single or divided by curricula, where the programme has provided for them, as formulated by the selection committees.

The annual amount of the scholarship, which is determined in accordance with art. 1 of D.M. 23/02/2022, no. 247, amounts to \in 16.243,00 gross of employee benefit expenses borne by the recipient.

The scholarships reserved to applicants having graduated in a foreign university, which are not assigned to any applicant, may be reassigned pursuant to the Regulations governing the University PhD Programmes.

Scholarships have a duration of one year and are renewed on condition that the PhD student has completed the programme of activities foreseen for the previous year, verified according to the procedures established by the PhD Course and in compliance with any additional requirements foreseen by the funders, without prejudice to the obligation to disburse the scholarship following the successful completion of the verification.

The benefit of a scholarship for the attendance of a PhD Course is compatible with the possession of a gross annual personal income not exceeding €16,243.00 in the calendar year in which the scholarship is received.

The PhD scholarship will start on 1 November 2025, unless there are any reassignments or delays, and can't be combined with any other scholarships, except for those given by national or foreign institutions to help PhD students do research abroad, or with research grants.

The scholarship amount is increased by 50% for periods spent abroad, subject to the availability of the relevant financial coverage. The scholarship increase is incompatible with Erasmus, Ulisse or any other contributions provided under international mobility programmes.

The request for the above-mentioned increase, addressed to the Rector, is subject to the authorisation for a period abroad issued by the Course Coordinator, within the limit of six months, by the Course Council















for longer periods.

The scholarship payment is made on a deferred monthly basis.

In the event of renouncement of the scholarship by the doctoral student or revocation following a negative evaluation or failure to comply with reporting obligations or in any other case for which the revocation of the scholarship is attributable to the actions of the doctoral student (except as already provided for in Articles 4, 5 and 11 of this Notice), the University reserves the right to require the doctoral student to return the scholarship.

Those who have already benefited, even partially, from a scholarship for a Doctorate course may not benefit from it a second time.

For foreign nationals, the payment of the scholarship is conditional on the presentation to the competent offices of the University of the Italian Tax Code issued by the Italian Consulate with territorial jurisdiction or by the Revenue Office (Agenzia delle Entrate), in the case of a candidate already present on Italian soil. Therefore, payment of the study grant cannot proceed, under any circumstances, until the Italian Tax Code has been duly presented.

ART. 14 – Tuition fees

Fees for admission to and attendance of PhD courses set by the Academic Bodies of this University amount to $\underline{\mathbf{\notin} 490.00}$ for <u>the first yea</u>r (including the University's contribution, stamp duty, accident and third-party civil liability insurance cover and the regional contribution for the right to university study) and $\underline{\mathbf{\notin}} 474.00$ for <u>each of the following two years</u> (including the University's contribution, accident and third-party civil liability insurance cover and the regional contribution for the right to university study).

Payment of the tuition fee for the first year must be made through the electronic payment systems provided by pagoPA (<u>https://www.pagopa.gov.it</u>) by the deadline for enrolment, which will be indicated at the same time as the publication of the rankings. In the event of payment made after the indicated deadline, the relative late payment fee will be applied.

The fees for the following years must be paid via electronic channels as provided for by pagoPA by 31 December of each year or, in any case, within two months of the starting date of the year of registration. If the payment is made after 31 December, or the two months following the date of registration, penalties for late payment will be applied.

PhD students enrolled without a scholarship and disabled persons with a disability rating of 66% or more, who declare their status at the time of enrolment, are exempt from paying the University contribution, but not the insurance cover, stamp duty and regional contribution for the right to university study. Employees of affiliated organisations are required to pay tuition fees.

Scholars from foreign countries are exempt from paying the University contribution and insurance coverage but not stamp duty or the regional contribution for the right to university study.
