PUBLIC NOTICE FOR SCHOLARSHIP ASSIGNEMENTS TO UKRAINIAN STUDENTS WHO REGISTER OR ENROLL IN UNIVERSITY DEGREE COURSES AT SASSARI Academic years 2021/2022 - 2022/2023

Art. 1 Scope and recipients

The public notice for the scholarships to be granted to students from Ukraine, who enroll or register in the academic years 2021/2022 or 2022/2023 is hereby published.

The types and amount of scholarships are as follows:

- N. 25 scholarships, all costs included.
- N. 25 Scholarships, not all costs included.
- N. 25 Scholarships for free registration/enrollment in degree courses and master's degree courses.

Art. 2 Scholarships

Scholarships are as follows:

- Scholarships with all costs included: the annual scholarship amounts to 8,400 EUR (plus any tax charges paid by the university). Eligible costs include food, accommodation, basic necessities, free registration/matriculation (excluding the regional tax for the right to Education and the Stamp duty). The scholarship may be confirmed for the following year.
- Scholarships with not all costs included: the annual scholarship amounts to 5,400 EUR (plus any tax charges paid by the university). Eligible costs include basic necessities, free registration/matriculation (excluding the regional tax for the right to Education and Stamp duty). The scholarship may be confirmed for the following year.
- Scholarships for free registration/matriculation in bachelor's and master's degree courses, of annual duration, valid for the entire academic year. The scholarship may be confirmed for the following year.

Any extension following the enrollment in the following academic year is subject to the decisions made by the "OOGG".

For all scholarship beneficiaries, free Italian courses will be provided by the University Language Center (CLA).



Art. 3 Admission requirements

The participation in the selection process requires the possession of the following requirements, under penalty of exclusion:

- 1. Being enrolled in a Ukrainian University for the academic year 2021/2022, in a degree course compatible with a course offered by the University of Sassari.
- 2. Having a permanent address in Ukraine or having resided in Ukraine before 24 February 2022.
- 3. Not being enrolled in another Italian University for the academic year 2021/2022 (transfers from other Italian Universities are not eligible).
- 4. Not being a beneficiary of other grants.
- 5. Having at least an A2 level of Italian or English (CEFR framework).

Applicants are also required to hold a residence permit for international protection (refugee status or subsidiary protection) or for "special protection" or for "temporary protection" or, alternatively, have requested recognition of international protection or "special protection" or "temporary protection".

The Selection Board will evaluate the assignment of the scholarship to holders of a different residence permit.

In the application form, applicants are required to specify the degree course, Master's Degree course or single teaching of the University of Sassari to which he/she intends to register or enroll.

Art. 4 How to apply and which documents to submit

The application must be submitted by midday of 10 June 2022, by filling in the form attached to this notice and sending it by Italian PEC registered e-mail to the following email address: protocollo@pec.uniss.it or by post to "University of Sassari, Piazza Università 21, 07100, Sassari".

If scholarships are available after the selection process, the call will be opened again, or a further notice will be published.

The following application documents must be submitted:

- 1) A copy of passport or other valid identification, in PDF format or in photo format with proof of entry into Italy.
- 2) A copy of the residence permit for "asylum", for "subsidiary protection", for "special protection" or for "temporary protection" or a copy of the request for recognition of one of the abovementioned forms of protection or a copy of the residence permit issued by the Italian authorities other than those previously listed.
- 3) A certificate of enrolment in a Ukrainian university with the list of exams taken.

The documents submitted by applicants must be in English or Italian; if the documents are in another language, a translation into English or Italian must be provided; a translation may be made, signed and

dated directly by the applicant, since at this selective stage, a certified translation in Italian of a document attesting to the validity of the qualification, the legalization or the "certificate of equivalence / Dichiarazione di Valore" of the qualification are not necessary.

Incomplete applications will not be accepted, and documents will not be returned.

The University reserves the right to request any other document considered necessary for a thorough evaluation of the application.

Art. 5 Assessment criteria, drafting and approval of beneficiary list

The selection panel appointed by the Rector among will include the Prorectors/Delegates competent in their subjects and a set number of officers working in the same Office as the Person responsible for the procedure.

The Panel will assess the fulfilment of the admission requirements and then draw up the ranking list, according to the date of submission and considering the courses for which each applicant applies to.

The Panel will draft the ranking list from the highest to the lowest score and will transmit it to the Person responsible for the procedure for the preparation of the final beneficiary list.

Beneficiaries applying for a degree course or master's degree course having a restricted access for which registration or enrolment will not be possible, may make a different choice or, alternatively, he/she may reject the scholarship and the following beneficiary will be assigned it.

The final beneficiary list may only be published the University's website: www.uniss.it

Art. 6 Acceptance and transfer of scholarship

The beneficiaries will be notified by e-mail to the e-mail addresses provided in the application form, as well as to their institutional e-mail addresses, if already assigned to them.

Each beneficiary is required to send the confirmation of acceptance, no later than 10 days after the scholarship notification date, under the conditions described in the public call, communicating the bank account details, under penalty of forfeiture. At the same time, each beneficiary is also required to register or enroll in individual courses of the degree and master's degree courses for the academic year 2021/2022 or 2022/2023 of the University of Sassari.

In case of non-acceptance or rejection, scholarships may be awarded to eligible applicants ranked in an appropriate position of the beneficiary list.

The scholarship will be paid in four quarterly instalments of the same amount, the first of which will be transferred only when the following conditions are met:

- 1. Completion of enrolment/registration procedure at the University of Sassari.
- 2. Residing in the provinces where the university branches are located (Sassari, Alghero, Olbia, Nuoro e Oristano).

3. Opening a bank account or being issued a pre-paid card having an IBAN code registered or coregistered in the name of the beneficiary.

The scholarship will be revoked if the beneficiary decides to move to another Italian or foreign University, drop-out or non-renewal of enrolment to the following year.

It will also be revoked if the beneficiary does not earn at least 50% of the university credits (ECTS) provided for in their study plan within the special supplementary examination session, except for those registered in the academic year 2021/2022 for which the deadline is set on 31/12/2023.

Art. 7 Personal data processing

The acquired data will be processed mainly with IT procedures and only in the context of the selection for which they are provided, and the procedures associated with it. The data will be stored, in compliance with the rules of E.U. Regulation 2016/679, relating to the protection of individuals with regards to the processing of personal data, for the period strictly necessary for the use of the data in the context of the related administrative procedure. The provision and collection of data are mandatory for the selection procedure, and, in case of sensitive data, such provision and collection are carried out pursuant to the Law No. 104 of 5 February 1992 "Framework Law for Assistance, Social Integration and the Rights of Disabled Persons", and Law No. 68 of 12 March 1999 "Norms for the Right to Work of Disabled Persons".
