**HAVING** REGARD to EU Regulation 2016/679, governing the code regarding the protection of personal data and Legislative Decree 196/2003 (Privacy Code);

**HAVING REGARD** to Regulation (EU) no. 2021/241 of the European Parliament and of the Council of 12 February 2021, published in the Official Journal of the European Union L57 of 18 February 2021, establishing the European Union Recovery and Resilience Facility;

**HAVING REGARD** to the decision of the ECOFIN Council of 13 July 2021, approving the evaluation of the Recovery and Resilience Plan for Italy and notified to Italy by the General Secretariat of the Council with note LT161/21, of 14 July 2021,

**HAVING SEEN** the Operationals Arrangements (OA) relating to Italy's PNRR, with which the periodic verification mechanisms are established (valid until 2026) relating to the achievement of the









goals and objectives (Milestone and Target) necessary for the recognition of the half-yearly reimbursement installments of the resources PNRR in favor of Italy, stipulated on 28 December 2021,

**GIVEN** Mission 4 "Education and Research" of the National Recovery and Resilience Plan and in particular the C2 component - investment 1.1, Fund for the National Research Program and Projects of Significant National Interest (PRIN) of the National Recovery and Resilience Plan, dedicated to projects of significant national interest;

**HAVING SEEN** the Ministerial Decree n. 1141 of 7 October 2021 so-called Guidelines for system initiatives of Mission 4: Education and Research – Component 2: From research to business;

**GIVEN** the Decree of the Minister of Economy and Finance of 6 August 2021, published in the Official Journal general series no. 229 of 24 September 2021, through which the financial resources foreseen for the implementation of the interventions of the National Recovery and Resilience Plan (PNRR) and subsequent amendment of 23 November 2021 are assigned to the individual administrations;

**HAVING** REGARD to the Interministerial Decree of 7 December 2021 which adopts the guidelines aimed at promoting equal gender and generational opportunities, as well as the employment inclusion of people with disabilities in public contracts financed with the resources of the PNRR and the PNC;

**HAVING** REGARD to the transversal principles envisaged by the PNRR, such as, among other things, the principle of contribution to the climate and digital objective (so-called tagging), the principle of gender equality and the obligation to protect and enhance young people;

**GIVEN** the art. 238, paragraph 4, of Legislative Decree 9 May 2020, n. 34, converted with amendments by Law 17 July 2020, n. 77, which provided for the increase of the FIRST Fund for the year 2021 by 250 million and for the year 2022 by 300 million euros, in order to prepare a new program for the development of Projects of Significant National Interest (PRIN) which, due to their complexity and nature, require the collaboration of multiple universities or research bodies;

**GIVEN** the art. 1 paragraph 172 of law 23 December 2014, n. 190 with which it is established that a share equal to at least fifty percent of the FIRST is allocated to the financing of PRIN projects, which for the year 2022 amounts to €18,751,292.50;

**GIVEN** Directorial Decree no. 104 of 02/02/2022, PRIN 2022 call, aimed at promoting the national research system, strengthening interactions between universities and research bodies and encouraging Italian participation in initiatives relating to the European Union's Framework Program for research and innovation;









**HAVING REGARD** to DD1580 of 14 October 2022 which implemented the procedures governed by the DD.DD. n. 104 of 2 February 2022 (PRIN 2022 call) and n. 1409 of 14 September 2022 (PRIN 2022 PNR Notice), to the aforementioned art. art 28, paragraph 2 quater, of the Decree-Law of 17 May 2022, n. 50 converted with amendments by Law 15 July 202, n. 91;

**HAVING** REGARD to the Decree of admission to funding from the Decree Register R.0000972 of 06/30/2023, with which project proposals relating to the LS - Life Science macro-sector, ERC LS6 Sector "Immunity and infection: immunobiology, aetiology of immune disorders" are admitted to funding, microbiology, virology, parasitology, global and other infectious disease, population dynamics of infectious disease diseases, veterinary medicine" including the Project entitled "Genomics of Trichomonas vaginalis associated mycoplasma species to define the contribution of mobilome mycoplasma drug resistance, pathogenicity, and microbial symbioses (Mymo: MYcoplasma MObilome)" – Prot. 2022ZJE2FH - CUP J53D23001270006 of which Dr. is responsible for the unit. **HAVING SEEN** DD n. 836 of 19 May 2022, with which the MUR, in compliance with the procedures referred to in art. 4, paragraph 3, of the notice determined the economic availability for each ERC sector;

**CONSIDERING** that with the aforementioned DD n. 836 of 19 May 2022, the LS " *Life Science*" *macro-sector* was assigned financial resources for a total amount of €259,635.077, of which 77,890,523 reserved for projects presented by PIs under the age of 40;

**CONSIDERING** that the total amount assigned to the project Prot. 2022ZJE2FH entitled "Genomics of Trichomonas vaginalis associated mycoplasma species to define the contribution of mobilome mycoplasma drug resistance, pathogenicity, and microbial symbioses (Mymo: MYcoplasma MObilome)", amounts to 201,714.00 euros of which 100,857.00 euros assigned to the Head of the Sassari unit, Dr. Daniele Dessì;

**CONSIDERING** that by signing the Deed of Obligation, the scientific coordinator and the Heads of Research Units undertake to respect the terms, conditions, methods of implementation as well as the reporting obligations envisaged by the call and its annexes, by the decree of admission to financing and the related Annex B - Disciplinary for granting concessions;

**REFERRING** to the Statute of the University of Sassari;

**RECALLING** the Rectoral Decree n. 1022 of 22 March 2022, which issued the University Regulations for the awarding of research grants on the basis of art. 22 Law 30 December 2010, n. 240;

**REFERRING** to the code of ethics of the University of Sassari;









**RECALLING** the resolution of the Council of the Department of Biomedical Sciences dated 26/10/2023, with which it is requested to proceed with a competition notice for the attribution of n. 1 research grant lasting 18 months, possibly renewable, for the development of the research project entitled: "Genomics of Trichomonas vaginalis associated mycoplasma species to define the contribution of mobilome mycoplasma drug resistance, pathogenicity, and microbial symbioses (Mymo: MYcoplasma MObilome)" for Area 05 - Biological Sciences, macro-sector 05/I – Genetics and Microbiology, competition sector 05/I2 – "Microbiology", disciplinary scientific sector BIO/19.- Microbiology.

The amount including the charges to be borne by the proposed administration is equal to euro 45,000.00 (forty-five thousand/00).

The scientific director of the research grant will be Prof. Daniele Dessì. The expense, for which financial availability has been verified, will be borne by the PRIN 2022 Dessì - CUP J53D23001270006 project.

#### Article 1

A public comparative procedure is announced, based on qualifications and interview, for the assignment of n. 1 research grant for 18 (eighteen) months at the Department of Biomedical Sciences of the University of Sassari, in accordance with art. 22 of Law 30 December 2010, n. 240, paragraph 4, letter b, as specified below:

#### **Project title**

Genomics of Trichomonas vaginalis-associated mycoplasma species to define the contribution of mobilome to mycoplasma drug resistance, pathogenicity, and microbial symbioses ( MyMo : MYcoplasma MObilome)

# Required profile:

MSc Degree in Biology and Biotechnology fields, with a track record of research activity of at least two years. Previous hand-on experience in molecular and cellular biology methods or

PhD-Doctoral degree in biological and biotechnological disciplines. Previous hand-on experience in molecular and cellular biology methods.

#### The research activity will be aimed at: (Italian and English):

Characterization of the contribution of the different mobilome profiles of selected strains of M. hominis to the immunopathogenesis, to the mechanisms of symbiosis with T. vaginalis, to antibiotic resistance

#### The research will be aimed at:

Elucidating the contribution of mycoplasmal mobilome profiles to drug resistance, immunopathogenesis, and establishment of the symbiosis with T. vaginalis.

# Article 2

#### Requirements for admission

Italian or foreign candidates in possession of at least one of the following specific requirements are eligible to participate in the comparative procedure:

- a) Master's degree in biological and biotechnological disciplines, with documented research activity lasting at least two years in the fields of microbiology/cell biology/molecular biology. Previous experience in molecular biology and cell culture methods.
- b) PhD in biological and biotechnological disciplines. Previous experience in molecular biology and cell culture methods.

Possession of a research doctorate is to be considered a <u>preferential qualification</u> for the purposes of admission to the selection referred to in art. 1 of this decree.

The relevance of the specific requirements will be assessed by the Judging Commission.

The requirements to obtain admission must be met on the deadline for submitting applications.

For qualifications obtained abroad, the candidate must indicate the details of the provision certifying their recognition in Italy in accordance with current legislation (declaration of equivalence).

In the absence of said recognition, the candidate may present the declaration of equivalence for the purposes of the competition obtained pursuant to art. 38 of Legislative Decree 165/2001 and subsequent amendments . by the competent Italian authority or, pending the release of said declaration, it will be mandatory to integrate the application for participation with the appropriate









attachment to the notice (equivalence request form for academic qualifications obtained abroad). Furthermore, in the absence of recognition of equivalence or while awaiting the declaration of equivalence for competition purposes, the selection commission will evaluate the equivalence of the qualification obtained abroad exclusively for the purposes of admitting the candidate to the selection and, to this end, the candidate must attach the local declaration of value issued by the Italian diplomatic-consular representation competent for the territory in the state to which the qualification refers or other useful documentation to allow its evaluation.

Candidates in possession of an academic qualification obtained abroad who cannot deliver the requested documentation by the deadline of the comparative evaluation procedure will be admitted with reservations and will have to deliver the documentation required by the announcement in the event that they are included in the merit ranking.

This Administration guarantees equality and equal opportunities between men and women for access to work and treatment at work.

#### Article 3

#### Application for admission and submission deadlines

The deadline for submitting applications, written on plain paper, addressed to the Director of the Department of Biomedical Sciences - University of Sassari, Viale San Pietro n. 43/b - 07100 Sassari, is twenty days (20 days) starting from the day of publication of the comparative procedure notice.

The application for admission and the related attachments, including publications, must be sent exclusively via PEC (Certified Electronic Mail), addressed solely to the following institutional PEC address of the Department: <a href="mailto:dip.scienze.biomediche@pec.uniss.it">dip.scienze.biomediche@pec.uniss.it</a>, indicating the following text in the subject: application for participation in the public comparative procedure for 1 research grant PRIN2022DESSI' - surname and name of the candidate.

For the application and the attached documents, static and non-directly editable formats must be used, without macro instructions or executable codes, preferably in .pdf or . tiff , avoiding proprietary formats such as .doc, . xls and others.

It is recommended to use personal PEC (certified email) as the preferential channel for transmitting participation applications.

Applications for participation <u>must be received within the deadlines set by the comparative procedure.</u> When submitting applications, the office registration date will prevail.

Applications that do not arrive within the deadline established in the competition notice will not be taken into consideration.

Any corrections and/or additions to the application form beyond the established deadlines will not be accepted.

In the application and related attachments, <u>duly signed where required under penalty of exclusion from the procedure</u>, the candidate must indicate:

- your surname and name, date, place of birth and tax code;
- municipality of residence and address;









- the citizenship he/she holds;
- to enjoy civil and political rights (if not an Italian citizen, even in the state of belonging or origin);
- that they have not had any criminal convictions or any convictions reported, indicating the details of the relevant sentences, and any criminal proceedings pending against them;
- that he/she has not been dismissed from his job in a public administration due to persistent insufficient performance and that he/she has not been declared forfeited from a state job;
- to be registered on the electoral lists, specifying the Municipality and possibly indicating the reasons for non-registration or cancellation from them;
- to have adequate knowledge of the Italian language (only for candidates of citizenship other than Italian)
- that they have no family or affinity ties up to and including the fourth degree with a professor belonging to the Department of Biomedical Sciences or with the Rector, the Director General or with a member of the Board of Directors of the University;
- that there are no causes of incompatibility and/or exclusion from the competition with reference to what is indicated in the art. 8 of this notice;
- the existence of any employment relationships, whether subordinate or self-employed, in progress;
- any enrollments in degree courses, PhD courses with scholarship or specialization schools;
- the possession of one of the specific requirements provided for by the art. 2 of this decree.

Candidates recognized as having a disability must specify in the application the assistance needed in relation to their handicap, as well as any need for additional time to complete the tests, pursuant to law no. 5 February 1992. 104.

The application must indicate the address that the candidate elects for the purposes of the comparative procedure. Any possible variation thereof must be promptly communicated to the Department of Biomedical Sciences of the University of Sassari to which the request for participation was sent.

The University Administration assumes no responsibility for the unavailability of the recipient and for the dispersion of communications resulting from incorrect indication of the address by the candidate or from failure or late communication of the change in the address indicated in the application.

Furthermore, the university administration does not assume any responsibility for any failure or late delivery of communications relating to the competition for reasons not attributable to the fault of the administration itself but to postal or telegraphic problems, third parties, fortuitous circumstances or force majeure . .

The application form which interested parties can usefully comply with is attached to this decree (Annex A).

Candidates must attach to the application form:

copy of the valid identification document with photograph and copy of the tax code;







- dated and signed professional curriculum of your scientific activity;
- qualifications that can be assessed for the purposes of the procedure;
- dated and signed list of attached titles;
- any publications;
- any documentation showing the details of the provision certifying the recognition in Italy, pursuant to current legislation, of the qualification obtained abroad, or documentation certifying the equivalence of the qualification for competitive purposes or the request for equivalence to competent Italian authorities.

Candidates must demonstrate possession of qualifications, excluding publications, through the form of simplification of administrative certifications permitted by the articles. 46 and 47 of Presidential Decree 445/2000 and by law 12 November 2011, n. 183 (stability law 2012), art. 15, filling in attachment "B".

The publications may be attached in the original or attached in a copy declared to be compliant with the original, pursuant to art. 19 of Presidential Decree 445/2000, by means of a declaration in lieu of the deed of notoriety referred to in art. 47 of the same Presidential Decree (annex C).

The candidate may use a form for each qualification presented, including the publications for which he/she intends to declare conformity to the original, attaching it to the qualification itself, or alternatively produce a cumulative declaration of conformity to the original of the qualifications presented. In this case the declaration must contain the information necessary to identify each individual title.

The declarations in lieu of certifications and the declarations in lieu of the deed of notoriety must be accompanied by a photocopy of a valid identification document with a photograph as required by Presidential Decree 445/2000. The administration reserves the right to carry out appropriate checks on the truthfulness of the content of the substitute declarations.

Reference to documents or publications presented to this or other administrations, or to documents attached to another application for participation in another competition, is not permitted.

The deeds and documents kept or issued by a public administration, as well as certifications of educational and service qualifications, must be attached to the application for participation using the form of simplification of administrative certifications permitted by the articles. 46 and 47 of Presidential Decree 445/2000, as amended by law 12 November 2011, n. 183 (stability law 2012), art. 15, according to which "The certifications issued by the public administration regarding states, personal qualities and facts are valid and usable only in relationships between private individuals. In relations with public administration bodies and managers of public services, certificates and affidavits are always replaced by the declarations referred to in articles 46 and 47", completing attachments "B" and "C".

#### Article 4

# Appointment of the judging commission and examination tests

The comparative evaluation procedure takes place based on qualifications and interview examination. The evaluation of qualifications precedes the interview exam.

The interview exam consists of a test aimed at ascertaining the level of preparation necessary to carry







out the research programme.

Furthermore, during the interview, knowledge of the English language will be assessed by reading and translating a scientific text.

For the evaluation of qualifications and the examination of candidates, a special judging commission has been set up, appointed by decree of the Director of the Department of Biomedical Sciences, upon proposal of the Department Council itself. The judging commission is made up of the person in charge of the research project and two other members, professors or researchers, belonging to the scientific disciplinary sectors relating to the advertised research project or similar sectors.

The decree appointing the judging commission will be published on the website of the University of Sassari at the address: <a href="https://www.uniss.it/ateneo/bandi">https://www.uniss.it/ateneo/bandi</a> in the section "Notices for teachers, researchers, research fellows and scholarship holders".

The Department will give written notice of the appointment to its members.

The Judging Commission, in relation to the comparative procedure, establishes the following evaluation criteria, analytically determined for the purposes of the overall evaluation <u>expressed in hundredths</u>, within the maximum limits indicated below:

# 40 points for titles, distributed as follows:

- the title of research doctor relevant to the scientific area put up for competition or to the research project referred to in the art. 1 of the selection notice: up to a maximum of 20 points;
- publications, specialization diplomas and certificates of attendance of post-graduate courses obtained in Italy or abroad as well as the carrying out of documented research activities at public and private entities with contracts, scholarships or assignments in Italy or abroad, as long as they are relevant to the scientific area put up for competition or to the research project referred to in the art. 1 of the selection notice: up to a maximum of 20 points.

# 60 points for the interview exam.

Passing the oral test is expected if the candidates are evaluated with a score of no less than 40 out of 60 points.

To take the test, candidates admitted subject to verification of possession of the requirements set out in art. 1 of the selection notice, they must have a valid identification document.

Candidates non-resident in Italy will take the oral test via Google Meet or Microsoft Teams platforms. It is therefore mandatory to include required Meet or Teams contacts in the application form.

At the end of the test, the Commission, based on the evaluation of the qualifications and publications presented by the candidates and any interview, formulates an opinion on each candidate, draws up the merit ranking and declares the winning candidate.

The candidate is included in the ranking if he/she obtains a score of at least 60 out of 100. The competition documents are approved by decree of the Director of the Department.







The Administration will communicate the outcome of the competition on the website of the University of Sassari at the address: <a href="https://www.uniss.it/ateneo/bandi">https://www.uniss.it/ateneo/bandi</a> in the section "Notices for teachers, researchers and fellows and scholarship holders", with a written note to the winners and only to the candidates placed in a useful position in the merit ranking.

Exclusion from the selections due to failure to meet the requirements set out in the art. 2 of the competition notice is issued at any time by reasoned decree of the Department Director.

# Article 5 Competition calendar

The competition calendar and the interview date are visible in Annex 1, which is an integral part of this decree.

#### Article 6

# Stipulation of the contract and start of the research activity

The awarding of the grant is formalized through the stipulation of a private law contract between the University and the winner.

The contract does not constitute an employment relationship and does not give rise to rights regarding access to other roles at the University of Sassari.

Starting from 2011, the tax provisions of article 4 of Law no. 13 August 1984 will apply to research grants. 476, as well as, in social security matters, those referred to in article 2, paragraphs 26 et seq., of law 8 August 1995, n. 335, and subsequent amendments; regarding compulsory maternity leave, the provisions of the decree of the Minister of Labor and Social Security of 12 July 2007, published in the Official Journal no. 247 of 23 October 2007 and regarding sick leave, art. 1, paragraph 788, of law 27 December 2006, n. 296, and subsequent amendments.

During the period of compulsory maternity leave, the allowance paid by INPS, pursuant to article 5 of the aforementioned decree of 12 July 2007, is integrated by the University up to the entire amount of the research grant.

The minimum gross annual amount of research grants, announced pursuant to art. 22 of law 30 December 2010, n. 240 is determined in a sum equal to €19,367/00 (nineteen thousand three hundred and sixty-seven /00 euros); this amount is net of the charges borne by the granting administration.

The allowance is exempt from tax but subject to social security withholding tax (subject to annual revaluation) according to law, and is paid in monthly instalments.

# Article 7 Duration and renewal

The grants may have a duration of between one and three years, linked to the duration of the project and subject to financial coverage, are renewable for periods of no less than one year and cannot be cumulated with scholarships of any kind awarded, with the exception of those granted by national or foreign institutions useful for integrating the holders' research activity with stays abroad.

The maximum duration of the grant, including any renewals, is six years, excluding the period in









which it was used coinciding with the research doctorate, within the maximum limit of the legal duration of the relevant course.

The overall duration of the relationships established with the holders of research grants and fixed-term researcher contracts referred to in art. 24 of Law 240/2010, stipulated with the same subject, cannot in any case exceed twelve years, even if not continuous. For the purposes of the duration of the aforementioned relationships, periods spent on leave for maternity or health reasons according to current legislation are not relevant

For research grants referred to in art. 3 of the University regulations, renewals are approved by Decree of the Director of the Department following verification of financial coverage.

The renewal application must be forwarded to the offices by the scientific manager, together with the report from the holder of the research grant on the activity carried out, at least 20 days before the expiry of the contract, having obtained the positive opinion of the Department of Biomedical Sciences and following the positive evaluation of the judging commission.

The judging commission is made up of the same members as the commission that carried out the comparative evaluation of the candidates.

In the event that one or more members of the judging commission are no longer available, due to forfeiture or impediment, they will be replaced by decree of the Director of the Department.

#### Article 8

#### Prohibition of cumulation and incompatibility

The research grant is individual; the holder of the same has the right to attend doctoral courses without the right to a scholarship, provided that he/she passes the admission test.

Holding the grant is not compatible with enrollment in undergraduate, specialist or master's degree courses, or with a research doctorate with scholarship in Italy or abroad.

Research grants cannot be stipulated with those who have a degree of kinship or affinity up to and including the fourth degree with a professor belonging to the Department of Biomedical Sciences, or with the Rector, the Director General or a member of the Board of Directors of the 'University. For employees working in public administrations, receiving a research grant entails being placed on leave without pay for the duration of the research grant, even if they are part-time employees.

For employees working in the university administration, the right to a research grant is excluded; private employees, even part-time, cannot benefit from research grants.

# Art.9

# Rights and duties of grant holders

The holder of a research grant has the duty to carry out the activity envisaged by the contract signed under the direction of the scientific manager, and has the right to use the structures and equipment of the Department in which he/she carries out the activity for research; if the activity must be carried out in external structures, it must be expressly authorized by the scientific manager and communicated to the Administration.

The research fellow's activity is carried out continuously, in compliance with the research program and according to the indications of the scientific director, who verifies the activity carried out.









The research fellow's activity is suspended due to maternity and may be suspended due to serious illness or serious family reasons, or for optional abstention; the periods of suspension, with the exception of the mandatory one for maternity which is extended by right according to current legislation, can be recovered at the end of the natural expiry of the contract, subject to agreement with the scientific manager and in compliance with any limits imposed by the funding available and without payment of compensation during the suspension period; a total period of justified absence not exceeding thirty working days per year does not constitute suspension and must not be recovered. The grant holder may carry out teaching activities, including paid ones, as long as such activity does not interfere with the profitable conduct of research activities, subject to authorization from the scientific director of the research; the holder of a research grant cannot replace teachers in teaching and institutional activities and in student evaluation.

The holder of the research grant is entitled to reimbursement of travel, food, accommodation and other reimbursable expenses incurred in Italy and abroad for reasons relating to the research project, within the scope of contributions for scientific research to layout of the reference structure, in accordance with the University regulations.

The holder of the research grant who intends to withdraw from the contract is required to notify the Rector and the Director of the Department of Biomedical Sciences with at least thirty days' notice. If, following the withdrawal by the holder, a period of activity exceeding one year remains, the Department of Biomedical Sciences has the right to proceed with the request for a new announcement for the remaining period; if, however, the remaining period is less than one year, a new tender is not permitted and the unused sums return to the availability of the Department that owns them.

The research grant is revoked by the Rector upon a reasoned request from the Director of the Department of Biomedical Sciences and the related contract is considered automatically terminated in the event of: serious failure to fulfill contractual obligations by the grant holder, unjustified failure or delayed start of the activity as well as unjustified suspension of activity and violation of the foreseen incompatibilities regime.
